Florida Action Committee postcards are intended to be mailed or distributed to RSOs. We want to reach out to them and their support circle of family and friends, to let them know how to contact our organization and join our mission. Together we will have a stronger voice to be heard on the reform of the laws.

These postcards are available in bulk packages for your personal distribution, or you can sponsor the cost of a 200-piece mass mailing that FAC coordinates completely.

Here's How it Works

Option 1: For Personal Distribution (SEE IMPORTANT INFO BELOW)

Simply let us know the *quantity and where* you want the bundle of postcards to be sent. The cards will be packaged and mailed to you so that you can distribute as needed. (Postcard postage rate is \$0.29).

Option 2: Sponsor a Mass Mail-Out

Your donation will cover the cost of addressing and mailing FAC postcards to 200 or more RSOs at one time through a mail house service in Central Florida. Let us know the region/city/or zip code vicinity that you want to notify. FAC takes care of the rest. The name list used can be sent to you upon request.

IMPORTANT INFORMATION

If you choose to address the cards to persons on the Registry, please DO NOT send to persons on supervision, probation or parole until is it cleared through the FAC Board. FAC will send an introduction letter to the local Corrections office in advance so that they are aware that the postcards are legitimate and approved by DOC.

Loose cards can be distributed at Treatment meetings, support groups, Legal offices, and housing communities where there is contact and support for RSOs. NEVER leave cards without approval. If they have questions or concerns, please notify FAC by email/phone with their contact info and a Board member will reach out to them.
